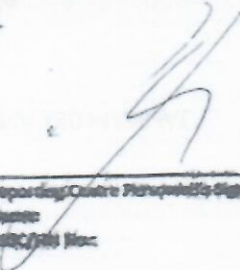
SKETCH PLAN

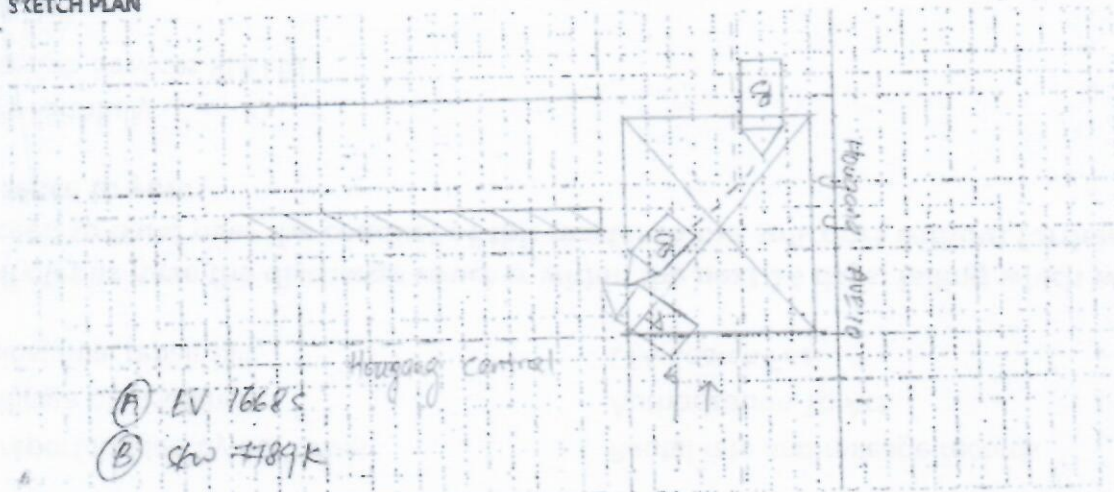
