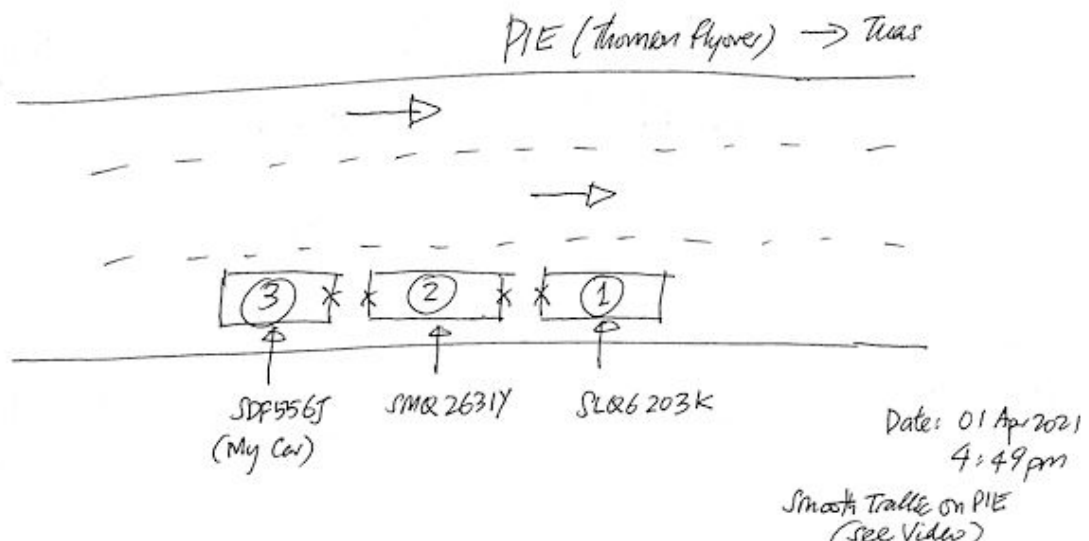

## Describe Circumstances of the Accident

On (5<sup>th</sup> Apr 2021 @ 4:49pm, I was travelling along PIE (4 lanes), with a smooth flowing traffic conditions (see video recording), on the extreme lane 1.

Suddenly, Car #2 (SMQ2631Y) came to complete stop and no hazard light was switched on. I was travelling around 70-80 km/h and could not brake in time thinking it was still moving on. I slowed as much as I could by braking but it has a slight bump onto Car #2.

When I alighted, I was surprised there is a Car #1 (SLQ6203K) that came to complete stop on lane 1 of PIE highway, where clearly the traffic was smooth sailing and there was zero traffic in front of Car #1.

Damages: Car #3

Upon inspection, my car (JDF556J) has a damaged car plate and small dent on my bumper, indicating the impact is minor collision.

Car #2 has small scratch/dent on right side bumper, and front bumper also has little or minor scratches only.

Car #1 has a dent on left side of back tailgate, but zero damage on his bumper. To my surprise, and photo of Car #2 front bumper could not have caused the dent or damage on this tailgate in my opinion.


10 mins after 5 mins we all agreed to pull to the side of road for taking down our particulars. An unsolicited Car #4 (SLZ1832E) number plate shows he is from "AP Automotive services tel: 96821148", the big tummy guy appeared and went to have a chat with driver of Car #1, and soliciting car workshop repair services from me and Car #2 driver. I have picture of Car #4 and the driver. I half suspect this accident is purely staged? Car #1 damage is inconsistent with bump from Car #2. And there is zero reason he should come to a complete stop on a free-flowing PIE highway!

Pls investigate thoroughly and if necessary advise me if a police report is necessary to stop all these staged accidents, as it could cause potential damage to property and lives as well.

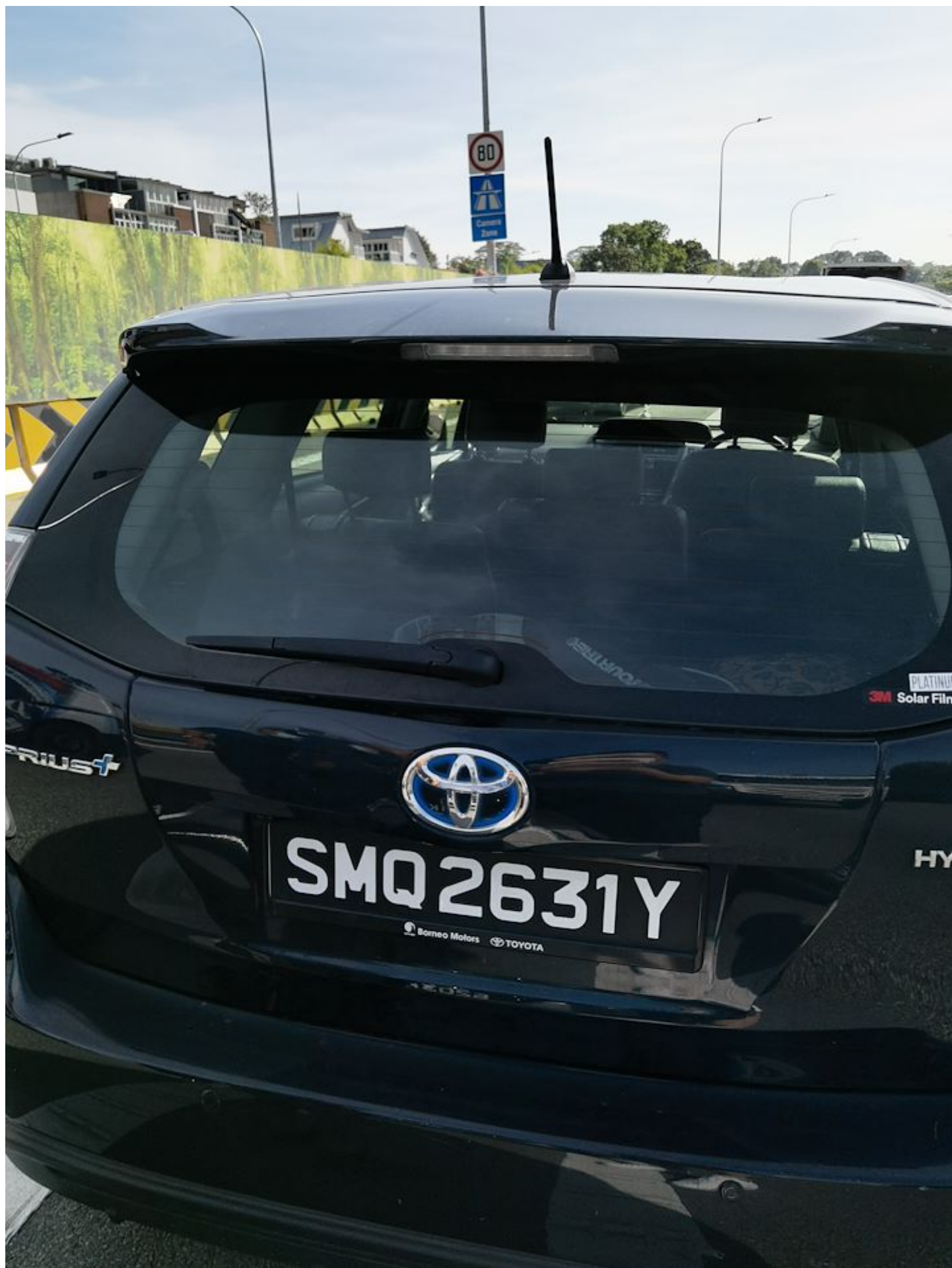
