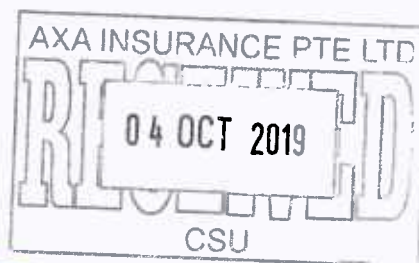



(a) However, the recommended cost of repair based on lump sum basis would be **\$5,300.00**


