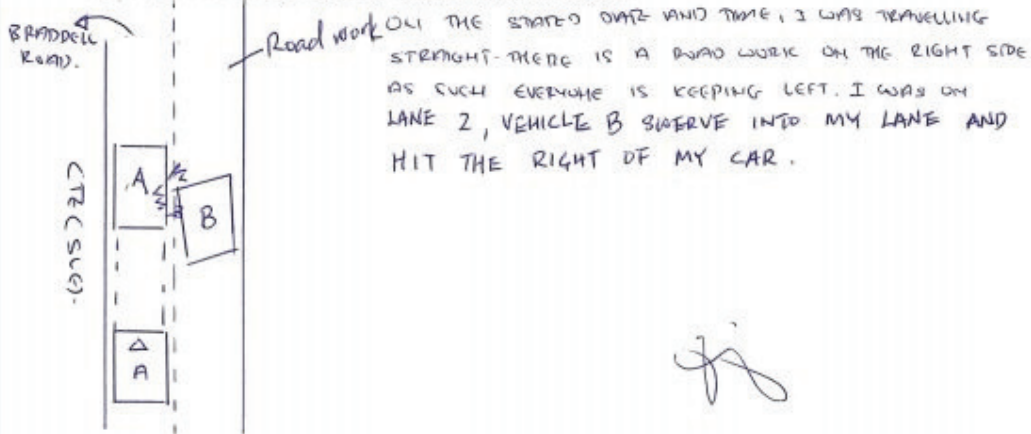

## Sketch plan

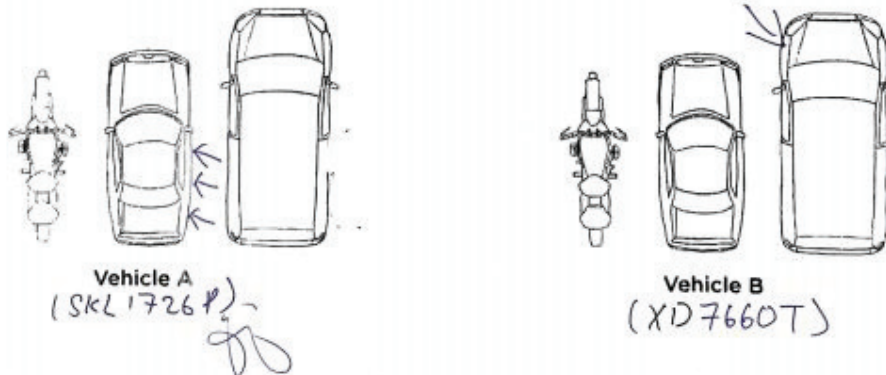
Sketch of accident scene:

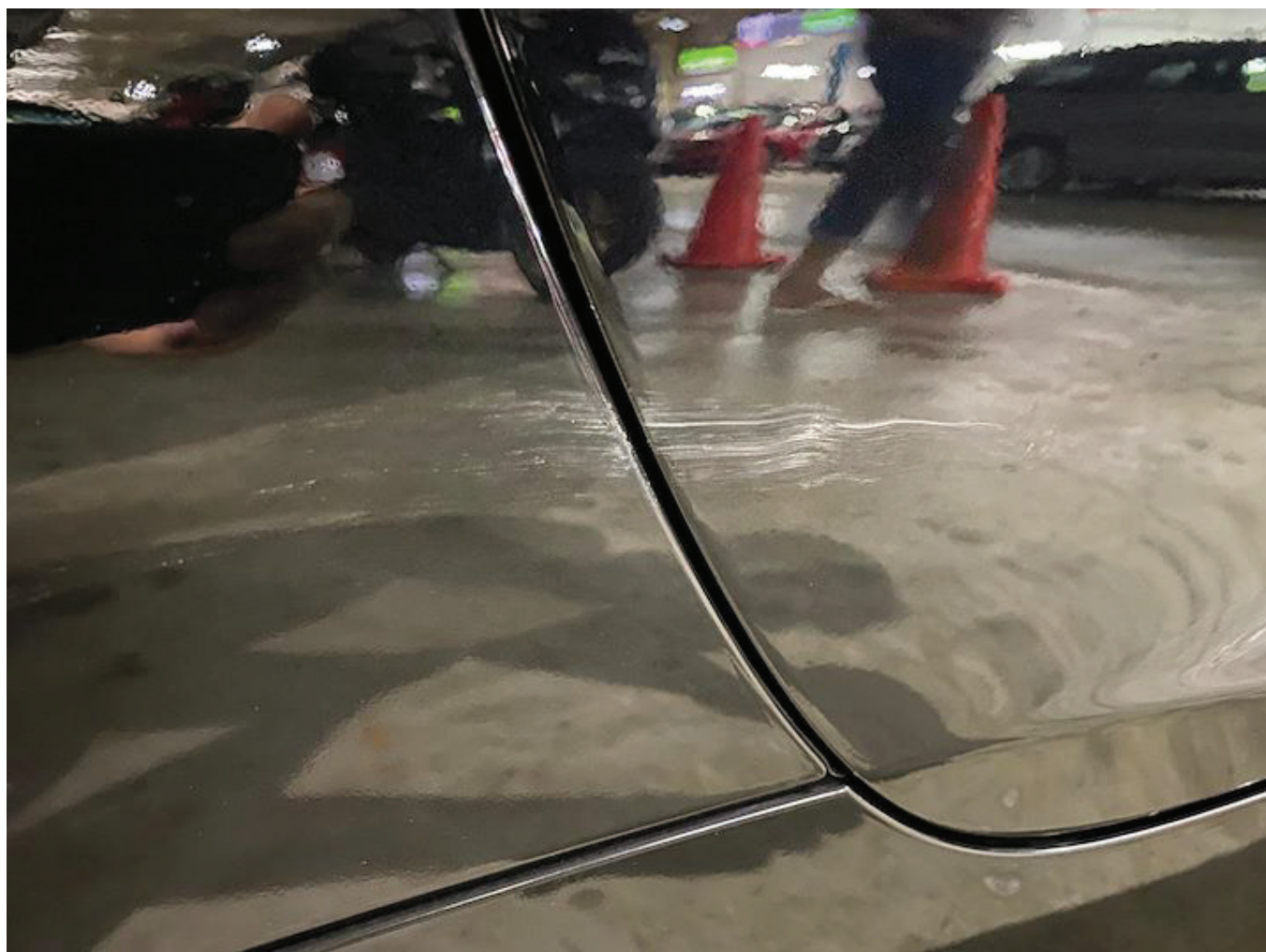
