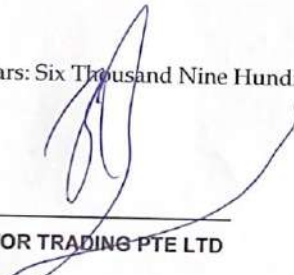

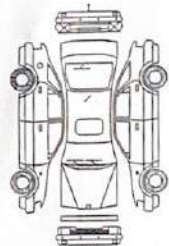

Brief Details.

On the stated venue, date and time, I, riding a motorcycle bearing the license plate FBC281R was making a right turn on the extreme right turning lane while a lorry bearing the license plate YK9401M, abruptly attempted an u-turn from the left lane beside me with the side of the lorry cutting through my path, I instinctively steer left but was not quick enough and so the inevitable happen, the rear of the lorry impacted onto me and I fell to my left along with my motorcycle.

Shortly after I was brought down in the middle of the junction, an SCDF ambulance arrived at the scene and attended to me and my injuries. The police arrived shortly after followed by a traffic police to the scene to assist.

I was conveyed to Sengkang General Hospital via the SCDF ambulance. I suffered injuries on my upper left rib cage, wrist and multiple abrasions on my body. I was discharge on the same day and received a 4 day mc from 12 March 2021 to 15 March 2021.

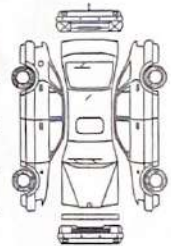

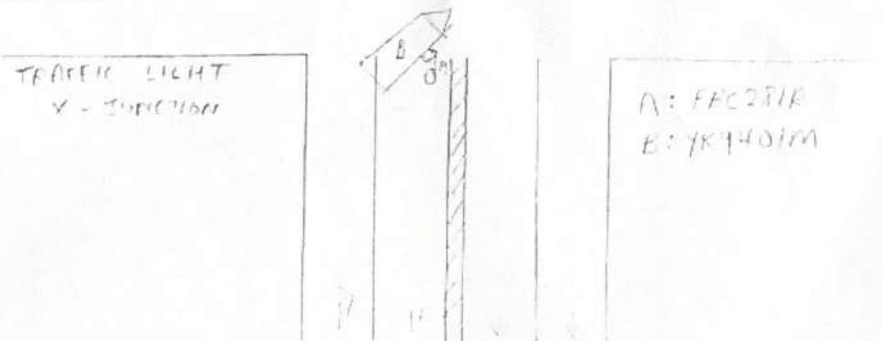
