#### Brief Details

On 26 Mar 2021 at about 1730hrs, I was riding my motorbike FBR8907M along Lentor Avenue towards Yishun. I was riding on the middle lane (of a 3 lane road). Traffic was heavy and congested and vehicles around ne were moving slowly and also coming to a stationary position. I stopped my motorbike in the middle lane, behind a vehicle to wait for the traffic to clear.

A few seconds later, auddenly, without warning, I felt a hard Impact from the near of my motorbike, I struggled to keep my self and my motorbike beliance, my motorbike felt to the right and I felt towards the front supporting myself with my right hand. I took somethins to get back my balance and while that was happening, with my perspectual vision I felt that the SMRT bus SG1163c hear tyre was very close to my left leg and hand. I also realised motorbike FBM62968 (note by Muhammad Infart Bin Jaki T01008012) has collided on the rear of my motorbike was the cause of this socident.

Both side of my notorbike were damaged due to the collision, the front wheel of the bike

became stanted and the fork shifted. The brake also became less effective after the accident

After the incident, Traffic Police came to asses the situation and view the coty footage from the SBS bus. He told me and the other biker involve to settle our calins with our insurances. Ambulances came and attended to us as we were injured, but the other biker and I did not convey to hospital.

Within about an hour after this accident, the pain from my injuries became unbearable, and I started to imp therefore went to Khoo Teck Pust Hospital and was given 5 days MC and was given a specialist letter to see for my shoulder and next higher.
