#### Brief Details

On 26 Mar 2021 at about 1730hrs, I was riding my motorbike FBR8007M along Lentor Avenue towards Yishun. I was riding on the middle lane (of a 3 lane road). Traffic was heavy and congested and vehicles around me were moving slowly and also coming to a stationary position. I stopped my motorbike in the middle lane, behind a vehicle to wait for the traffic to clear.

A few seconds later, suddenly, without warning, I felt a hard impact from the rear of my motorbike, I struggled to keep my self and my motorbike balance, my motorbike fell to the right and I fell towards the front supporting myself with my right hand. I took sometime to get back my balance and while that was happening, with my peripheral vision I felt that the SMRT bus SQ1183L rear tyre was very close to my left leg and hand. I also realised motorbike FBM6298B (rode by Muhammad Irfan Bin Jalil T01008012) has collided on the rear of my motorbike was the cause of this accident.

Both side of my motorbike were damaged due to the collision, the front wheel of the bike

became slanted and the fork shifted. The brake also became less effective after the accident.

After the incident, Traffic Police came to assess the situation and view the cctv footage from the SBS bus. He told me and the other biker involve to settle our claims with our insurances. Ambulances came and attended to us as we were injured, but the other biker and I did not convey to hospital.

Within about an hour after this accident, the pain from my injuries became unbearable, and I started to limp therefore went to Khoo Teck Pust Hospital and was given 5 days MC and was given a specialist letter to see for my shoulder and neck injury.
