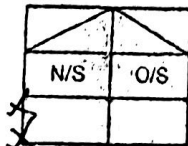

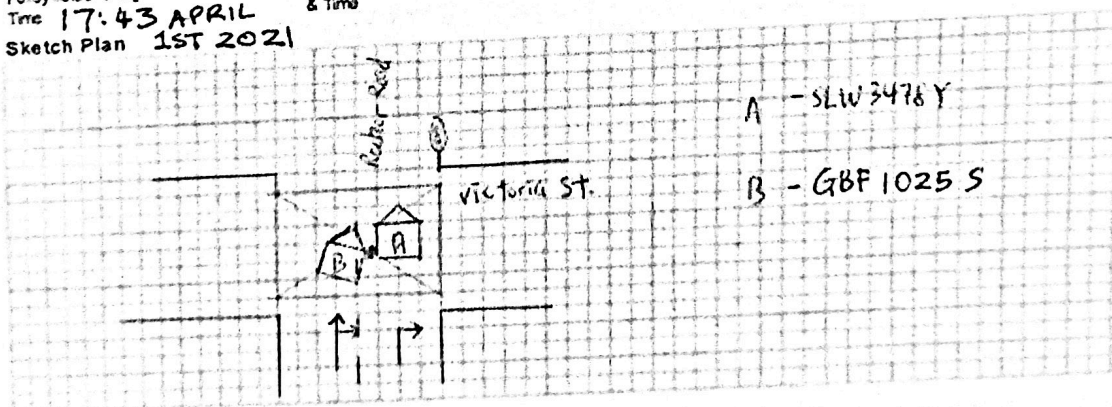

Describe Circumstances of the Accident

At about 6:43 pm I was driving along Rochor Road between Northbridge Road and Victoria Street. I had mistaken the right most lane that I was in for a right turn and straight-going lane. However the lane to the left of mine was actually the right turn and straight-going lane. Therefore ~~in~~ another vehicle GBF 10255 was actually turning right, while I was going straight. Just as I crossed the junction of Victoria Street, the other vehicle turned right and hit my left rear bumper/side panel above the wheelwell. Fortunately no one was injured. We drove to a side street (possibly Victoria Lane or Arab Street) to inspect the damage and exchange contact information. We also had a kind witness who was a pedestrian who stayed with us the whole time, observing the process as we took photos and documented the damage. The other vehicle was a lorry, driven by Seiladurai Panneer Selvam and there were 4 or 5 other workers with him. The witness was Mr. Adrian Tan Chong Jin. I was driving alone.
