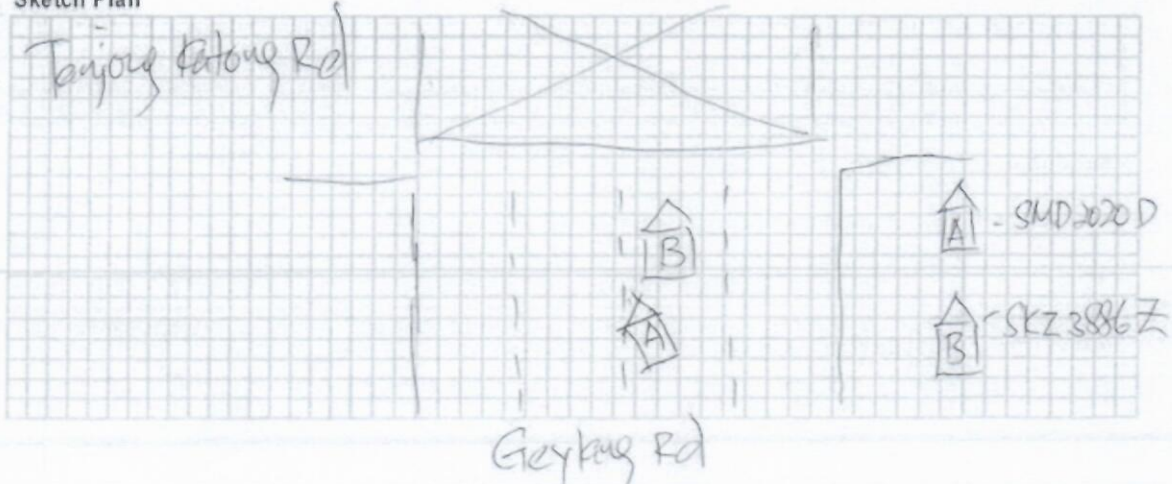

As I approached cross-junction (S) Geylup Rd / Tanjong Katong Rd, I signaled / indicated left.

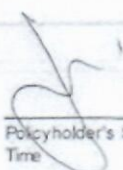
However the front car jammed brake. I could not brake in time, and hit its left rear bumper.
