ON MONDAY, 5 APRIL 2021, AT ABOUT 0100HRS, I HAVE JUST DROPPED OFF AT BUS STOP NO. 54371 ALONG ANG MO KIO AVE 10 TOWARDS THE DIRECTION OF ANG MO KIO DRIVE. AS I WAS MOVING OFF, I HAD ENTERED INTO THE LEFT LANE OF THE 2-LANE ROAD AND HAD THE INTENTION OF CHANGING LANE TO THE RIGHT LANE. I HAVE CHECKED MY MIRRORS AND SAW THAT I WAS CLEAR AS I WAS ABOUT TO SHIFT INTO THE RIGHT LANE. SUDDENLY, I HEARD A LOUD BANG TOWARDS THE FRONTAL RIGHT PORTION OF MY TAXI WAS COLLIDED BY MY TAXI BY SMV6474G. AMBULANCE AND TRAFFIC POLICE CAME TO THE SCENE BUT NO ONE WAS INJURED OR CONVEYED.
