On yesterday, we have spoken to OI, Doctor Yong, she called up AIG as she received a carbon copy of lawyer letter for this claim which she feels that it is not reasonable as the incident is very slight. OI said that she has spoken to Borneo Motor and will send an email to Borneo to add in 3 points in the accident report.
