

Describe Circumstances of the Accident

ON 12/04/2021 AT ABOUT 1420HRS, I WAS TRAVELLING ALONG ORCHARD ROAD TOWARDS CITY DIRECTION. JUST AS I APPROACHED THE TRAFFIC LIGHTS AT THE JUNCTION OF ORCHARD ROAD / ANSWILLA PARK, THE LIGHTS TURNED AMBER. ON SEEING THAT, I SLOWED DOWN AND MY VEHICLE (REGN NO: SJE 69H) CAME TO A STOP. MOMENTS LATER, I HEARD A BANG AND FELT MY VEHICLE JOLTED FORWARD. I IMMEDIATELY REALISED THAT THE VEHICLE BEHIND ME (REGN NO: SKA884E) HAD COLLIDED INTO THE REAR PORTION OF MY VEHICLE. (SJE 69H).
