In case, you have misunderstood our question, we are merely looking for instructions on how to proceed with the repairs. I understand the NORM or practice there is on the market. But this practice should not be unjustified. There is no provision or legislation that such a vehicle is to be repaired on a lump sum repair basis. Lastly, a lump sum repair basis with having the repairers warrant/ guarantee the repairs under "lemon law" for six months is also unfair. You have adjusted the repair cost with no parameters/ basis of adjustment yet, the law requires us to warrant the repairs.

As technical adjustors, I believe the instructions on how best to proceed with the repairs should come from yourself. Since the adjustment of replacing and repairing comes from you.

With that said, I do hope to hear from you soon, so as to ease my colleague's affair on the expediting of this case.
