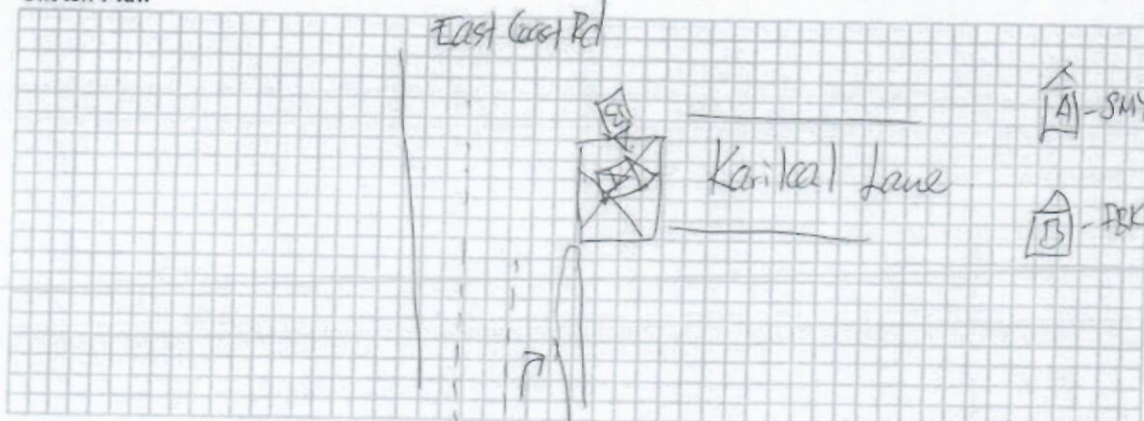

Sketch Plan

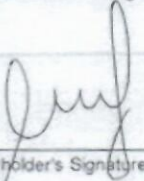
