

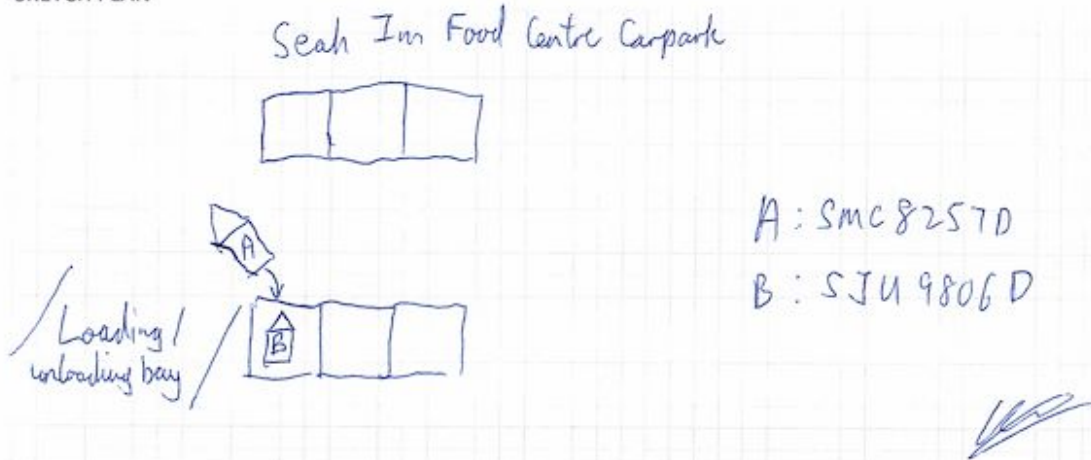

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I went to Seah Inn Food Centre Carpark to pick up a bicycle. As the owner of the bicycle was waiting near the loading/unloading bay, I stopped my car near the loading/unloading bay to load the bicycle into my car. As I was loading it, there was a lorry that was coming out of the loading/unloading bay. I was blocking the way of the lorry so I quickly loaded the bicycle and reverse my car quickly to give way to the lorry. The lorry driver kept sounding his horn to show his displeasure. In the end, as I hurriedly reverse my car, I unknowingly collided into the parked vehicle SJU 9806D. I realised I had knocked into a car so I parked my car properly and went to access the other car. There was no one in the car and I wanted to leave a note for the driver to contact me. That was when the driver came back and I told him about the collision. He said he rented the car and was due to return so he will leave it to the rental company to resolve this incident. Based on my assessment and photos, there were only minor scratches on the front left bumper. The next day, the rental company called to enquire about the incident we agreed to have a private settlement if possible. If they want to make a claim against me, they need to inform me first before taking any action. Since then, I have not ~~heard~~ hear from the rental company for 3 months and suddenly, I was notified of an insurance claim for this incident on 14 Apr 2021, more than 3 months later since the date of the incident. No body was injured in the incident.
