SUDDENLY, VEHICLE B WHO ALSO WANTING TO TURN ONTO CHANGI ROAD DROVE TO THE RIGHT HAND SIDE OF MY VEHICLE AND PROCEED TO TURN WITHOUT SIGNALLING. HOWEVER WHILE VEHICLE B WAS TURNING, HE CUT INTO MY LANE RESULTING IN THE LEFT HAND PORTION OF VEHICLE B HITTING ONTO THE RIGHT HAND PORTION OF MY VEHICLE.

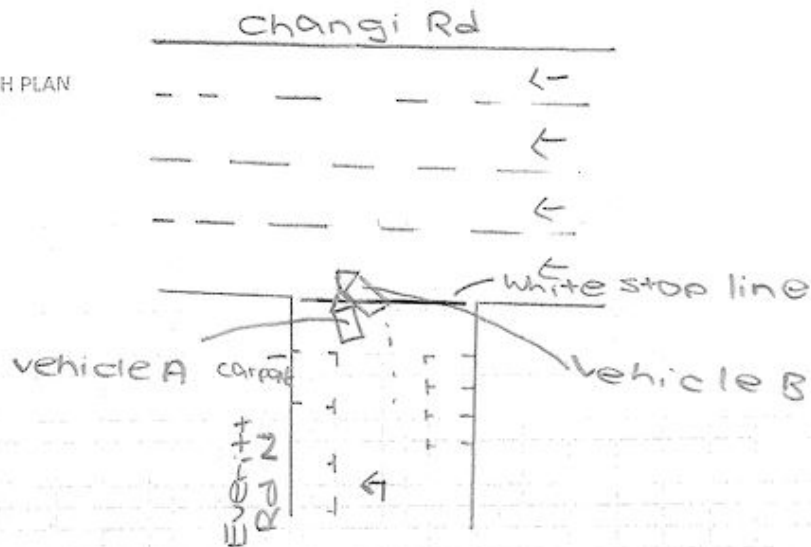
