Dear Bryan,

We refer to the above matter.

Thank you for the videos and screenshots you provided earlier.

The insured appears to agree that when the plaintiff's vehicle was at the entrance gantry at 10:49 AM, there does not appear to be any damage on the front right side of the plaintiff's vehicle. But he also said it was possible that the plaintiff's vehicle could have been damaged in the interim. He is wondering if there is any video footage of the plaintiff's vehicle in the interim period (between 10.49 AM to 11.33 AM) to confirm that the plaintiff was not involved in another accident. No. We did not obtain the footage for that period. We only obtained the footage showing the incident between insured vehicle and plaintiff's vehicle.

After further discussion with insured, he is still concerned with the consistency of damage on both vehicles. He says that he finds it strange that there are large dents on the plaintiff's vehicle but none on his. Essentially, he wishes to state his view as follows:-

- a. *his front right fender and bumper had been severely crumpled in, whereas mine was a tiny scratch mark (his is an Audi, continental car and mine a BMW – which, based on Newtonian physics, should expect to see similar if not equal imprints in a collision given that both are of like material and density);* If you zoom into the photos attached in insured's GIA report. The damage to the insured vehicle is not a tiny scratch mark, as highlighted by insured. It was deep scratches into the rear bumper. We inspected the insured vehicle more than 3 months after the incident and the scratch marks could still be clearly seen. The scratches marks had penetrated into the material of the rear bumper and not superficial scratch marks.
- b. *there were whitish paint and gravel marks on his car fender and bumper that could not have been left by mine as my car is entirely metallic grey (and suggests that his car may have previously collided into a concrete, white-painted object);* If you refer to page 23 of insured's GIA report, the damage of the Plaintiff's vehicle was shown. There was no concrete/powdery residue seen on the damaged area of the Plaintiff's vehicle to suggest that the damage was caused by collision with a wall or similar type of object.

Also, with regards to point (a) above, the insured says that it is possible that the plaintiff's damage could have been made worse after the accident as the insured only took photos of the plaintiff's damage 4 days after the accident. He is also wondering if there is CCTV footage showing the plaintiff's vehicle's condition after the collision. No. There is no footage.
