We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AXA Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a third party claim(s) from FASTECH AUTO PTE LTD acting on behalf of the owner of GBJ 4909B against your motor insurance policy.

We have reviewed the matter and based on all the available information on hand, we are of the view that we do not have a good defense towards the claim submitted by GBJ 4909B. Attached is a copy of video screenshot from GBJ4909B lorry. The video shows that third party was driving straight with traffic light green in his favour and third party had the right of way.
