

Brief Details.

On the stated date and time, I was driving my vehicle SKX4826B travelling straight along slip road Braddell Road towards Sims Avenue. When I was travelling along the right lane, suddenly I heard a bang from the front left portion of my vehicle. Vehicle SFQ8288Z cut into my lane abruptly and hit onto the front left portion of my vehicle SKX4826B. However, vehicle SFQ8288Z did not stop after the accident and drove away. I started to chase and horn him and finally we stopped at the road shoulder along PIE (Changi) before KPE. He refused to give his particulars. EMAS attended to the incident and requested us to exit the expressway to settle this incident. He then drove away without exchanging particulars. I sustained injuries due to the accident and was given 5 days of MC.
