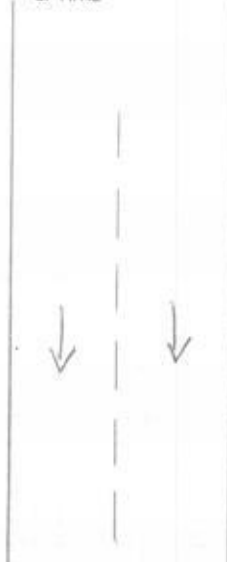

B: SMM 7404A


Describe Circumstances of the Accident


