Brief Details.

On 18 Apr 2021 ~6.25pm, I checked that the traffic was cleared and turned into Dunearn Road from Bukit Timah Road (opposite Cyan Condo) . I was within the speed limit, it was Sunday, we were not rushing, and my young daughter was with me in the passenger front seat, so I am careful. My car was in the yellow box / double white lines section when vehicle B suddenly crossed into my lane and hit me. Some parts of my car that was hit fell off and it was clearly shown in the photo (attached) that it was within the yellow box / double white lines area.

I do not have in car camera.

Vehicle B driver showed no sign of injury when he got out of the car. We exchanged our particulars; he was talking and breathing normally, he was walking normally too.

However, on 21 Apr 2021 ~6.35pm, I received a telephone call from Audi (my insurer authorised reporting centre) that Vehicle B driver has claimed injury so I am advised I need to make this police report now.
