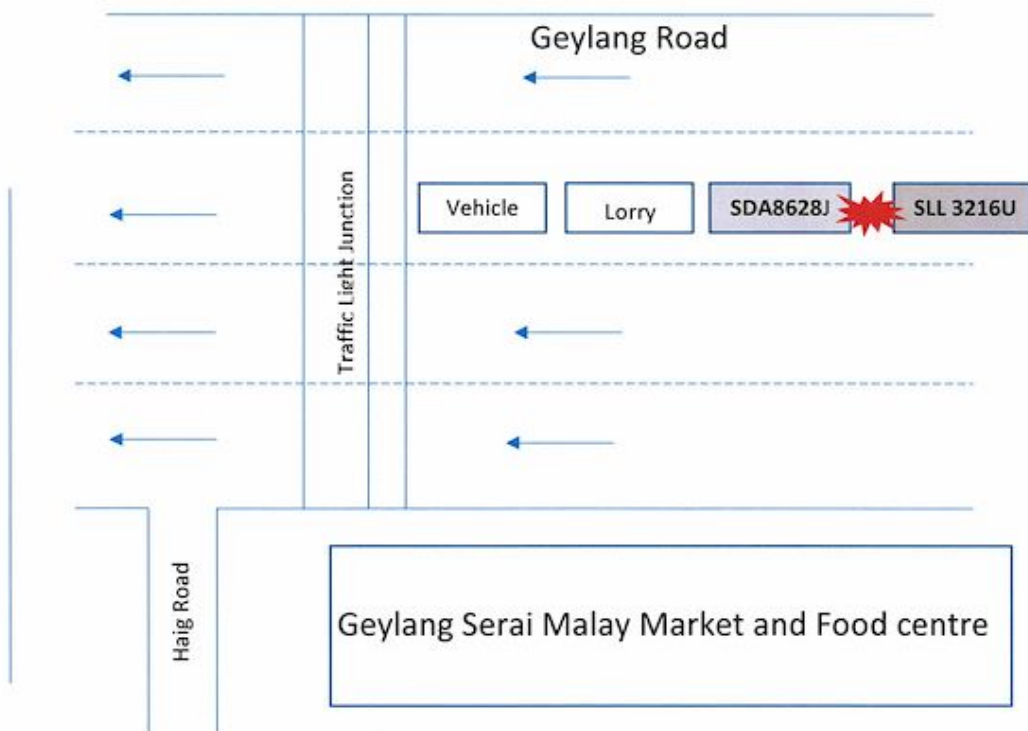
The weather was clear and the road condition was dry at the time of the accident.

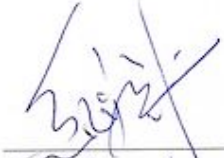
