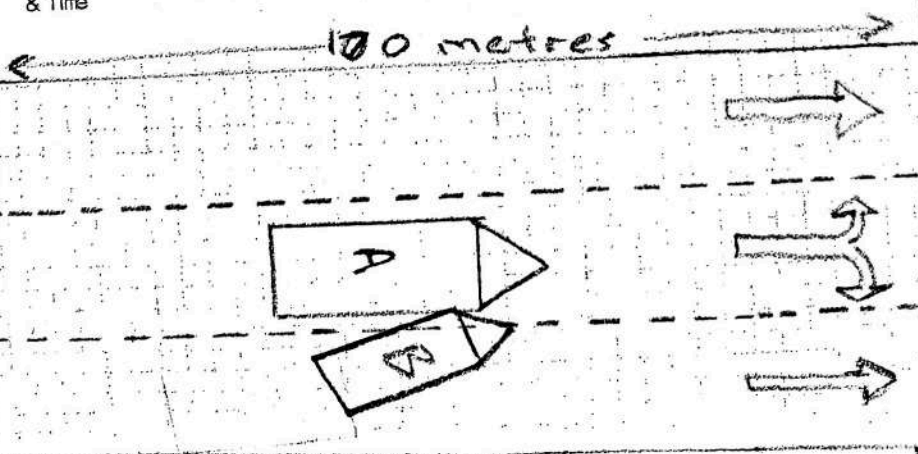

Brief Details.

On 18/04/2021 at about 4.00pm, I was driving my vehicle of plate number SLP8718J. I have just turned out from Minto Road onto Jalan Sultan Road, a 3 lane road. The left most lane is for left turn only. I turned to the middle lane of Jalan Sultan. I wanted to turn right onto Beach Road. The middle lane allows vehicle to turn both left and right onto Beach Road. Before reaching the traffic junction, which is about 50 meters away, a lorry came from behind, from the 3rd lane which is a right turn only lane, and swipe onto my car. The impact starts from the middle to the front of my car. I realized that my vehicle has been hit by a lorry of plate number GBC3192U. I went down and spoke to the lorry driver. He was travelling on the outer most lane which is a right turn only lane and he told me that he wanted to turn left into Beach Road.

I took some photos of the accident. I told him to make a U turn at the opposite side of Jalan Sultan and stopped our vehicles to exchange our details. He told me ok however after I make the U turn, he disappear.

I am working for Grab and my rental company advised me to lodge a traffic accident report. I have also informed my insurance company.
