Dear Kok Chong,

According to surveyor as below:

Spray painting should be 3 pieces at \$550 each and 2 door handle at \$100 each.

Therefore total spray painting is  $(3 \times $550) + (2 \times $100) = $1850/$ 

As for the supplementary spray painting, if the job is done at Premium Automobile, the breakdown will be as follow:

Front bumper spoiler=\$300

Front wheel arch cover =\$200 x2=\$400

Rear LHS wheel arch cover=\$200

Front and rear door cover=\$250 x2=\$500

Therefore total should be =\$300 + \$400 + \$200 + \$500=\$1400/-

However, if the supplementary spray painting is to be done by an independent workshop, his opinion is as follow:

Front bumper spoiler=\$150

Front wheel arch cover=2 x \$80=\$160

Rear LHS wheel arch cover=\$80

Front and rear door cover=2 x \$100=\$200

Therefore total should be \$150 + \$160 + \$80 + \$200=\$590/-
