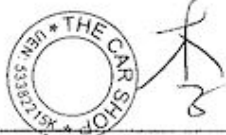

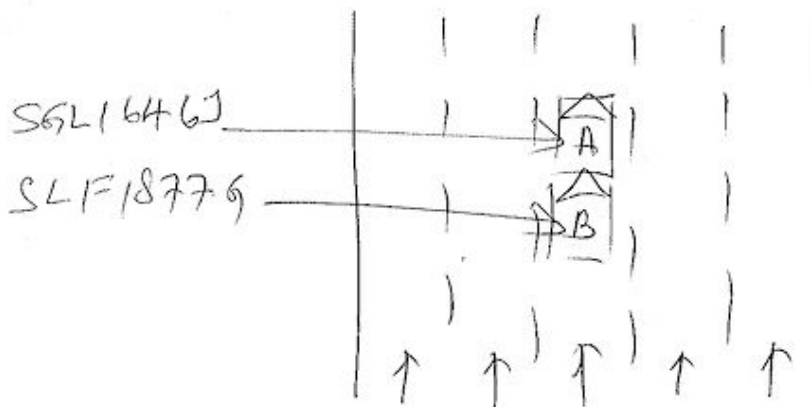

marina Boulevard



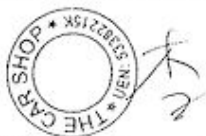
