My wife and I was not feeling well. We was consulted by doctor.

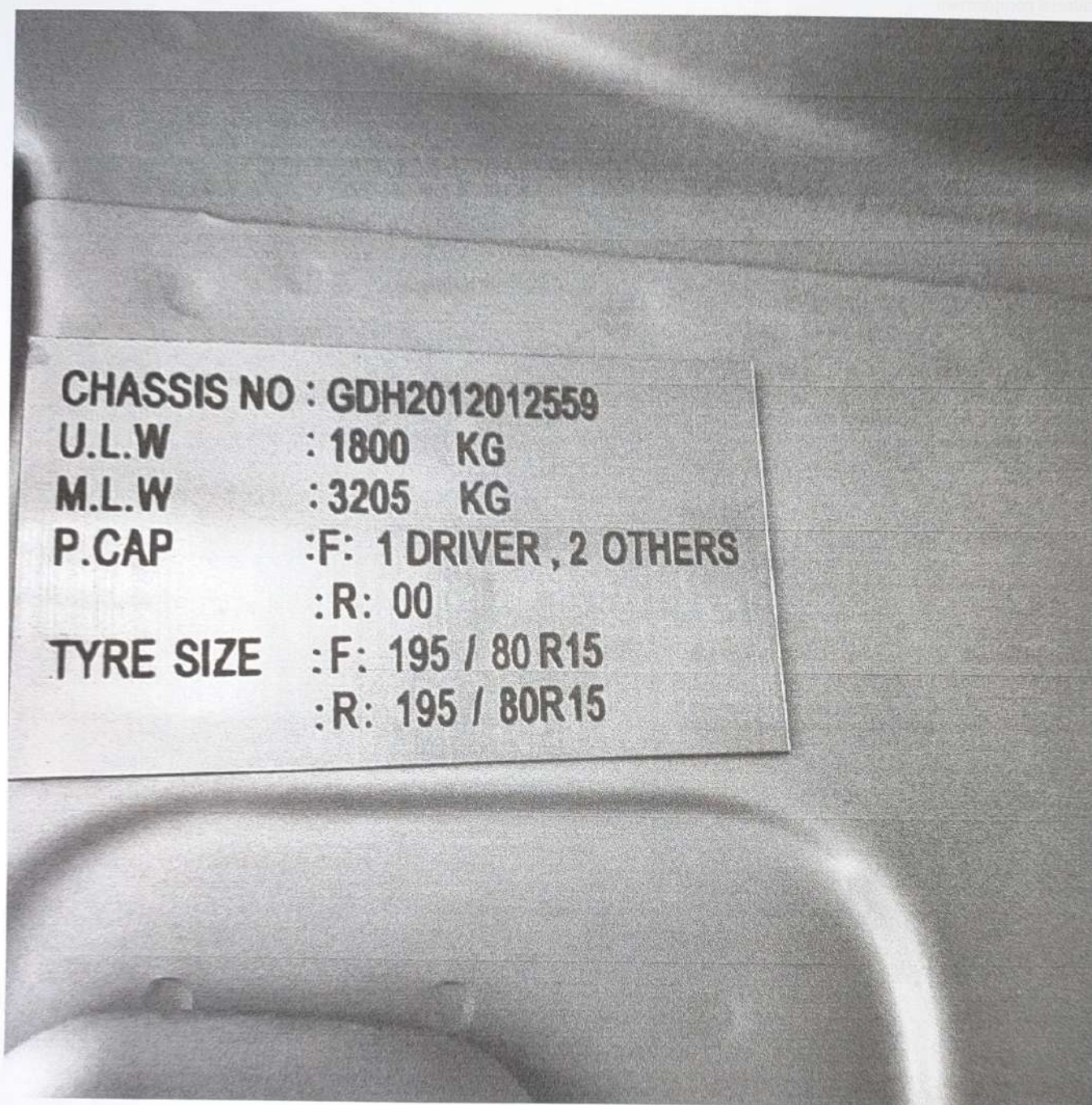

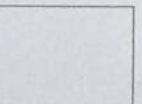
