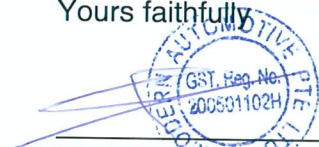



1. Any summons or violation of the traffic laws incurred during the duration of my use of the vehicle **(Toyota Wish SGJ1066T)** will be held responsible by me and I shall pay all the fine involved.
2. In the case of an accident happen during the period of my use of the vehicle **(Toyota Wish SGJ1066T)** with consideration of the cause of the accident, a sum of SGD \$4,000.00 will be paid by me to **Young Wheel Car Rental, (UEN: 53399813A)** for processing of damage claim and losses if the accident is caused or contributed by me.
