Brief Details.

On 5 October 2020 at about 6.30pm, I was riding my motorcycle FBF9969R travelling along Bukit Batok West Ave 9 heading towards Bukit Batok West Ave 5. When I was approaching the junction at Bukit Batok West Ave 6, the traffic light at my direction is still green, so I proceed to cross the junction. While I was crossing the junction, I noticed a lorry coming from the opposite direction. The lorry came to the junction and make a sudden u-turn. I was shocked and tried to manoeuvre my motorcycle to the left but it was too late. We collide, my motorcycle fell and I was thrown off from the vehicle. I tried to get up but could not move my right leg. A passers-by came to my assistance and help me to call for an ambulance. Later the ambulance came and I was sent to Ng Teng Fong Hospital.
