We have not heard from you since our last email.

As mentioned via our tele-conversation previously. Your vehicle's (Audi A4) reinforcement bars underneath the front and rear bumper covers are attached to the car with mounts that can absorb low-speed crash forces and then return to their original positions. With this restorable energy-absorbing systems, vehicles won't sustain as much damage, or maybe none at all, in many low-speed impacts.

However, for Third party's vehicle (Honda HR-V) doesn't include restorable energy-absorbing systems. The bumper bars are attached with mounts that bend and buckle during impact. There's only foam to absorb the energy of minor impacts but fails to keep the damage away from the car body. HR-V bumper is reinforced only in the middle.

Our surveyor had physically conducted survey to third party vehicle and is in the view that the damages sustained to the Third-Party vehicle is consistent to the nature of accident as reported.

Kindly let us have them in writing within the next **7 days** i.e. by **23/08/2021** if you will appeal for the Police Investigation Result. Otherwise, we shall proceed with negotiation with Third Party claimant on the without prejudice basis and any settlement should not bind any claims whatsoever by you/your driver against the other party's insurer arising from this particular accident.


