We have checked with our surveyor and his comments is as follows: -

- Kindly refer to the photo 6-9,15 in Merimen, show a warped number plate and the bumper area around the number plate can also be seen to be out of shape.
- Kindly refer to the photo 16-18 in Merimen, show that the headlamp lower apron(white colour) is already misaligned with the front bumper, hence signalling that the impact has deformed the front bumper.

Our adjusted repair cost is at L/sum \$10,200.00 with 11 repair days.

We are currently pending for third party LOD & documents to seek mandate from your good office. Thank you.
