



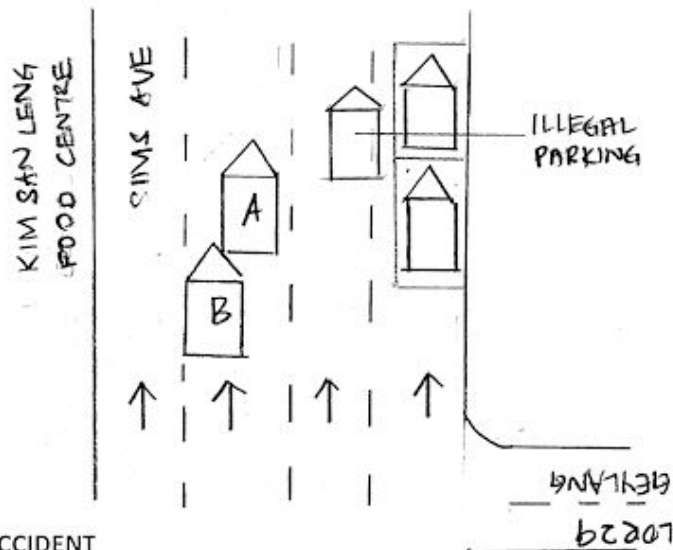

SKETCH PLAN



