
DAMAGES FOUND ON VEHICLE A & VEHICLE B

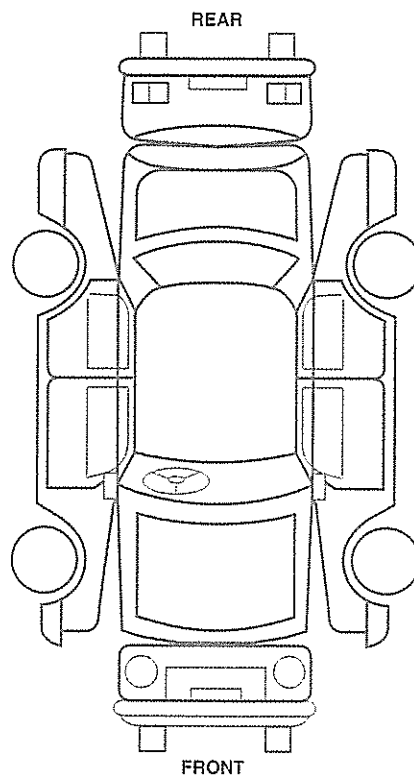
