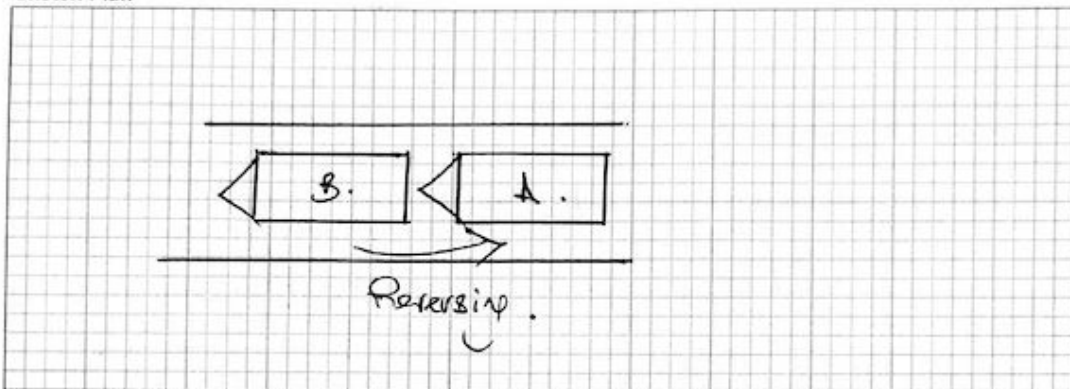





Brief details.

At around 5:23pm when I was about to exit the pick up point from fetching my wife, I noticed a private hire vehicle with registration number SLR9670U were obstructing the main exit area. I saw a security guard on duty instructing the driver of the said vehicle to leave the compound. I was then able to move off but at a very slow speed as I noticed the vehicle slowing down and intermittently stopping right at the slope (downward) of the main exit. I immediately stop moving when the vehicle made a sudden stop. Giving it the benefit of doubt, I didn't tap my horn as it could be due to some obstruction ahead of the vehicle and

remained patient. I then realised the vehicle was about to reverse when the indicator lights were on and at my stationary position, as I was about to honk, the vehicle accelerated it's reverse gear and bang right into the front portion of my car. The vehicle then speed off immediately and I gave a long honk while at the same time tailed the vehicle until it decided to stop.

The driver of the car got out without wearing a face mask while telling us to wait as he mentioned that he need to call his 'boss' and also informed his 'passenger'.

My wife then told him to wear his mask.

He made me wait for about 5 to 10 minutes before deciding to 'negotiate'.

Without even apologising and having a proper negotiation, he told me to 'go to his workshop' or if I were claim insurance, he verbalised that he would claim that I am the one banging him from behind instead.

This is when 2 of the security guards came forward and told me that they can be my main witness. They were Mr Shaik and Mr Teo. Mr Shaik also asked for both our contact details which the driver of the said vehicle gave reluctantly.

I also overheard the driver's conversation with his 'boss' James on the phone speaking in mix of mandarin and hokkien saying not to talk much with me and just move off immediately. Prior to this, the driver passed me his phone to speak with his 'boss' James, and I told James that I would want my car to be done at my preferred workshop but James denied my request. After which the driver started to ignore me and drove off.

I approached the security guard Mr Shaik to request for the cctvs footages as I noticed 2 different cctv which were clearly focusing the slope of the main exit where the incident happened. Mr Shaik advised me to follow up with the building management Ms Jasmine tomorrow.
