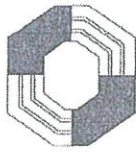

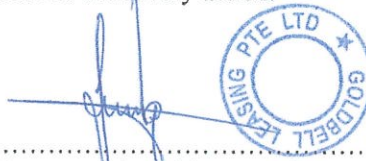

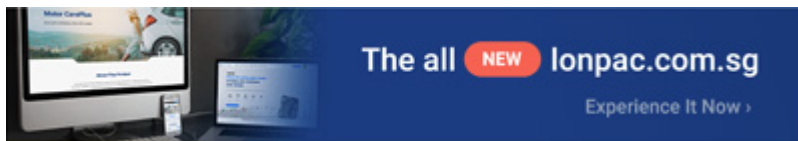
Please proceed to settle as per your recommendations.
