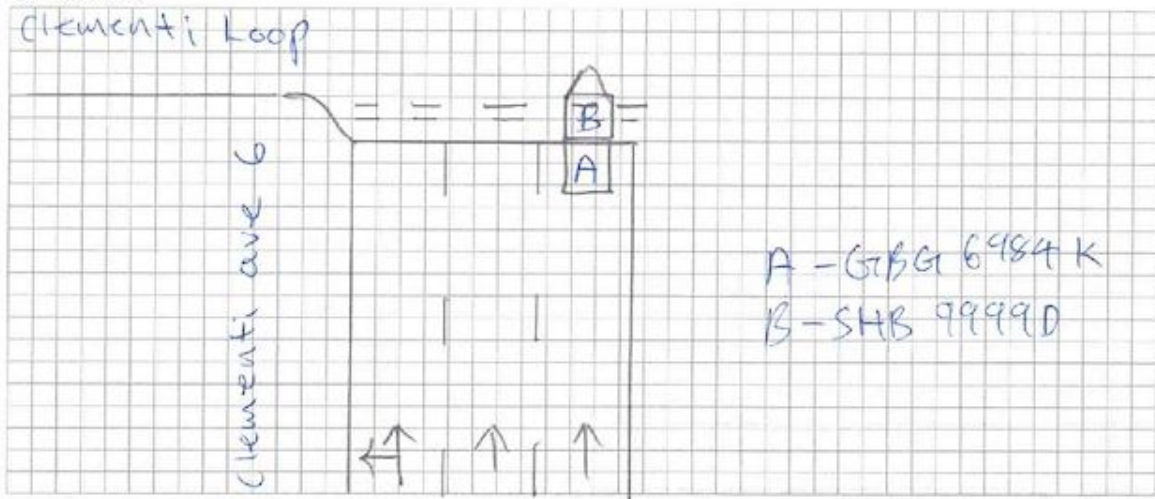

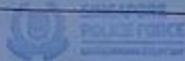

Brief Details.

On 07/05/2021 at about 1800hrs, I was driving my vehicle GBG6984K along Clementi Avenue 6 towards PIE. At the junction of Clementi Loop, a taxi SHB9999D in front of my vehicle jammed brake as he wanted to avoid the camera beside the traffic light although his taxi had passed the stopped line at the junction. I then rear ended his taxi but police and ambulance were not called in. We exchanged particulars and moved off. My vehicle has an in-car camera and had captured the incident.

I am lodging this report as instructed by my insurance company for their action as I believed the taxi driver had jammed his brake on purpose resulting in the collision.
