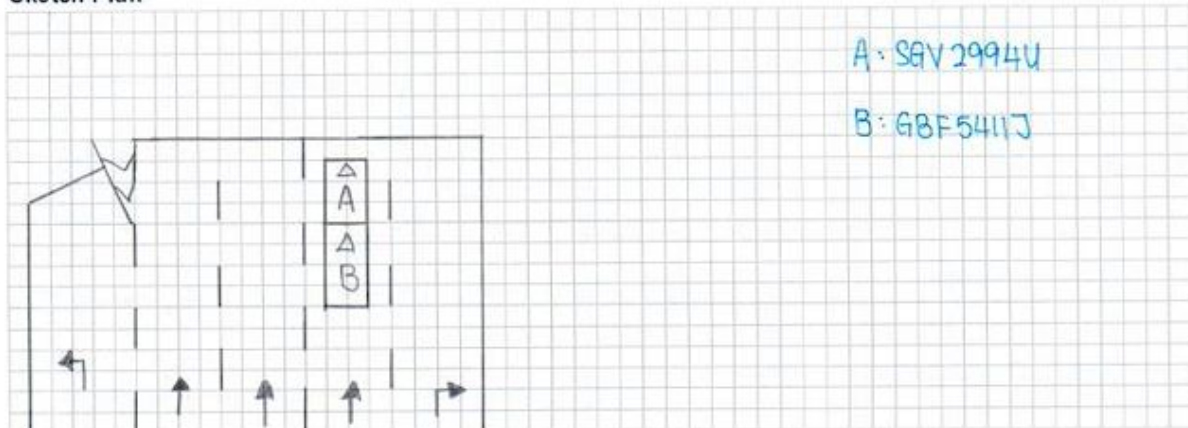

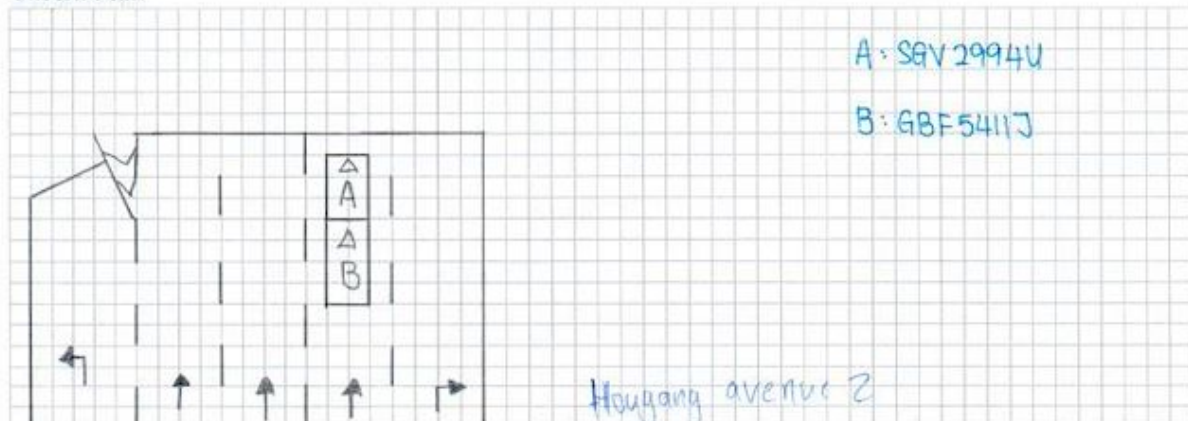

Sketch Plan



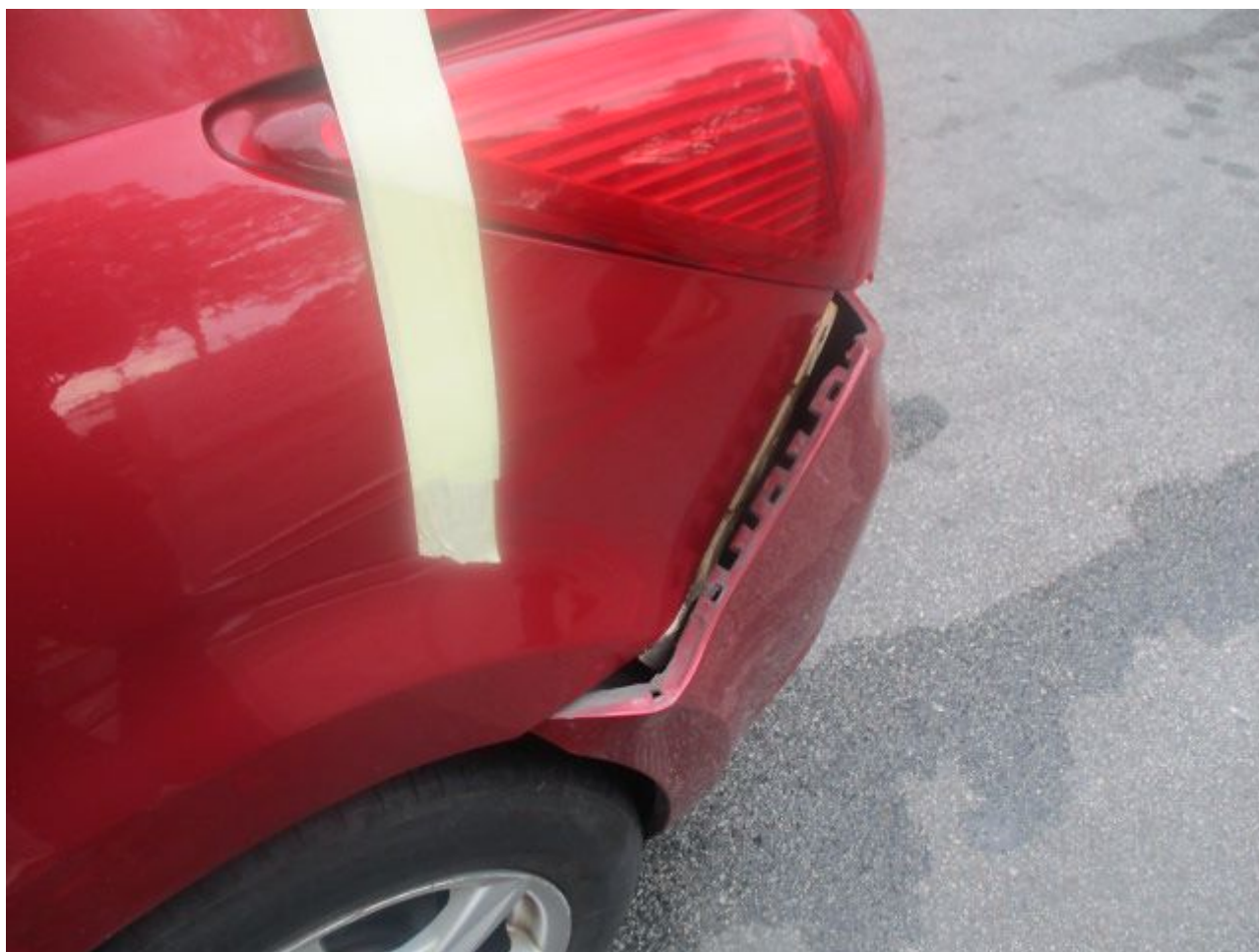


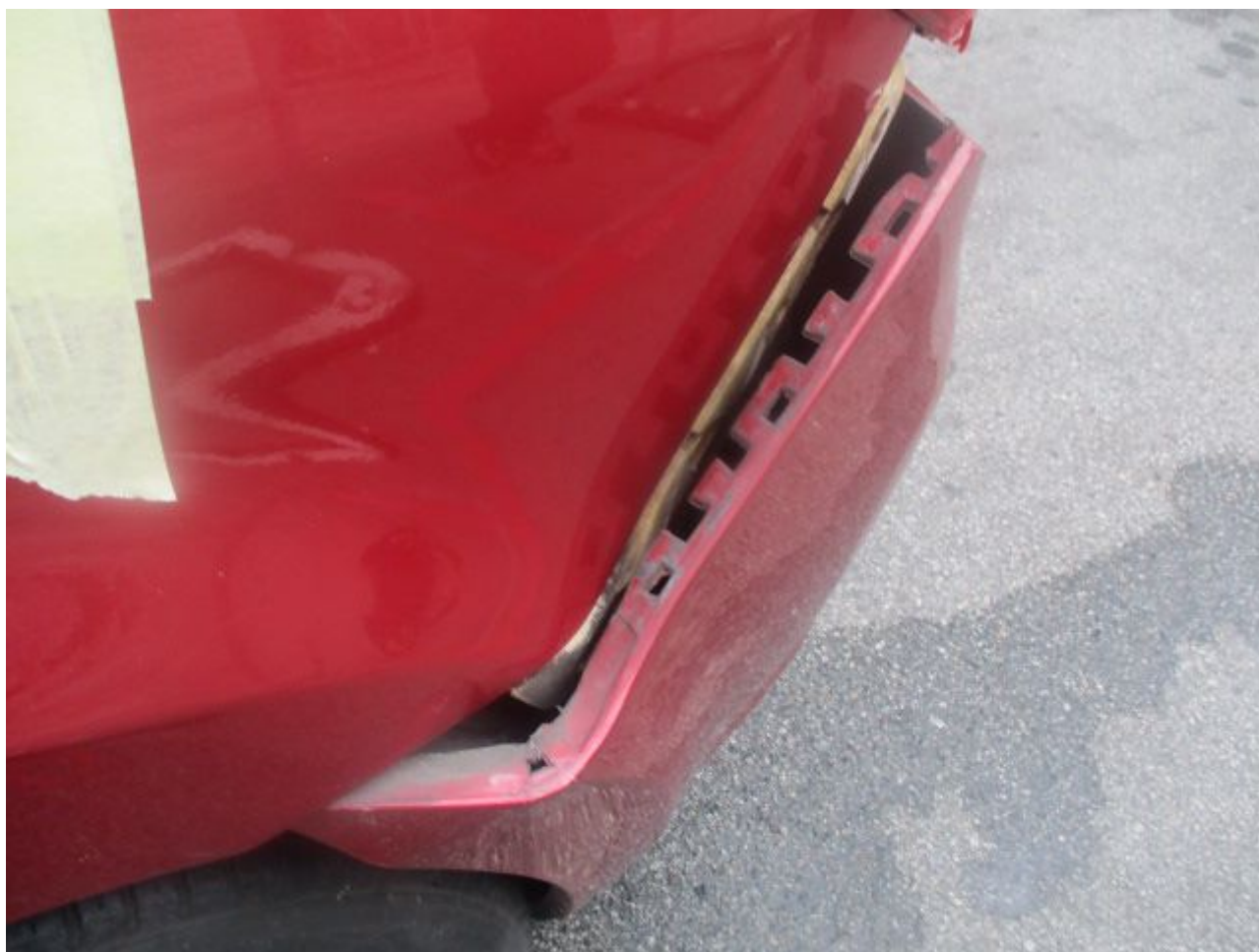








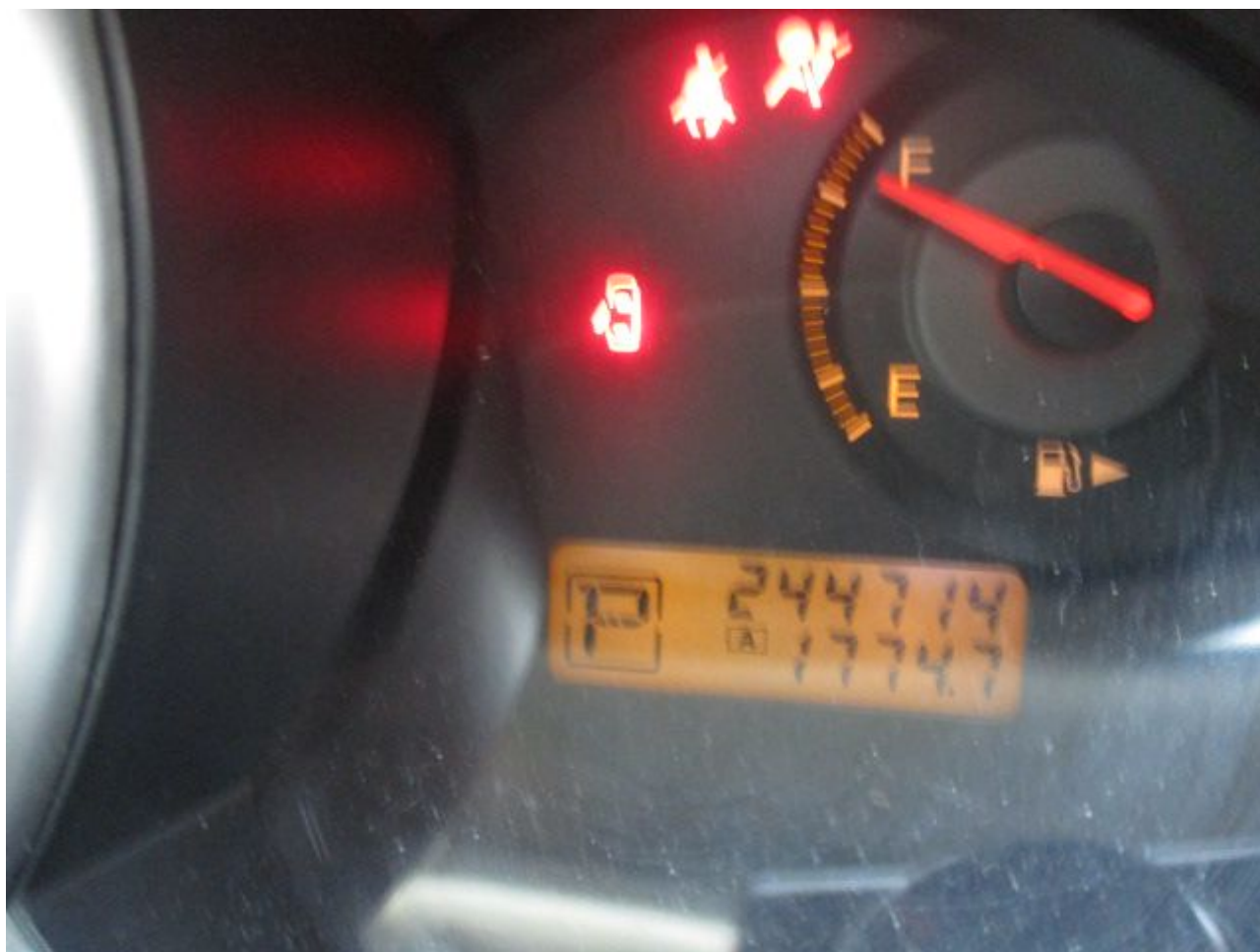


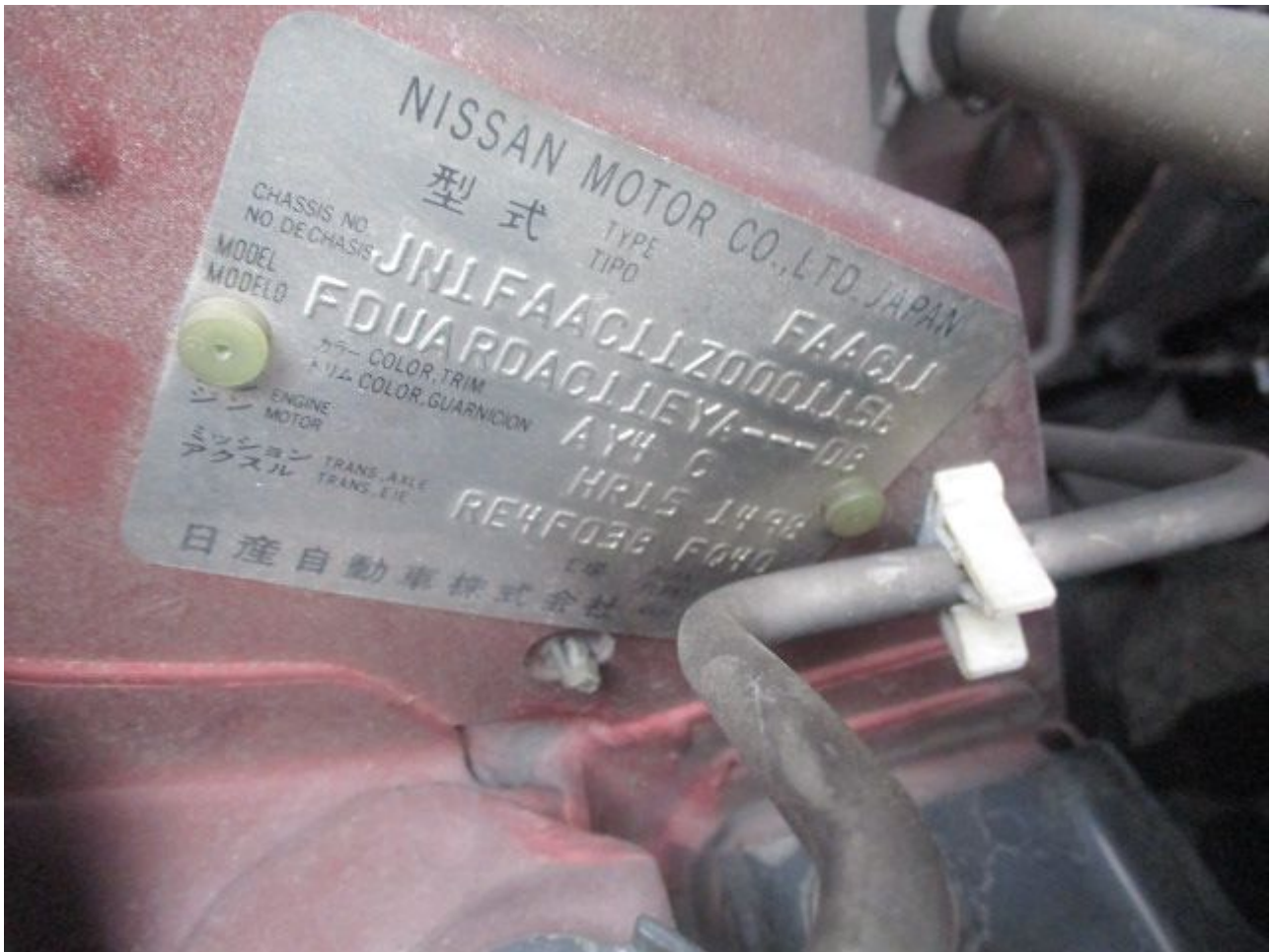
