I GOT OFF TO CHECK THAT THE DRIVER AND HIS PASSENGER WERE OK. THE DAMAGE TO THE TAXI WAS ONLY THE REAR BUMPER. THE TAXI DROVE OFF BUT I HAD TO GET MY CAR TOWED AWAY.




