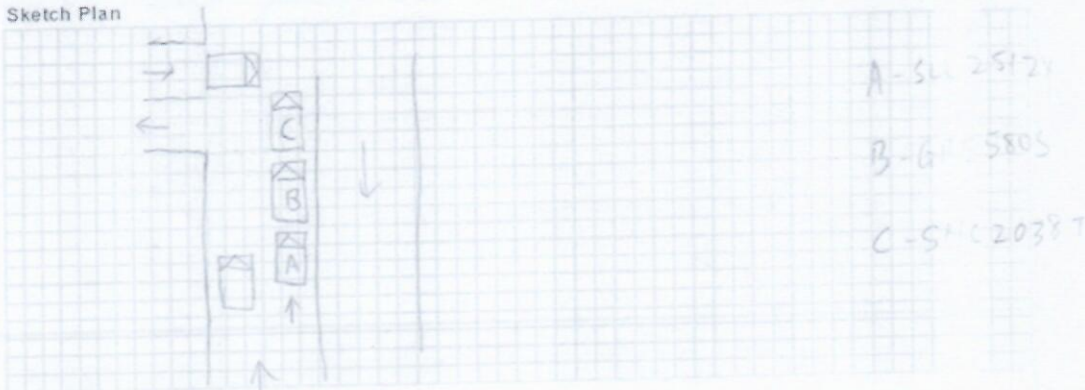

I was travelling along Kallang Way towards the direction of Aljunied Road.

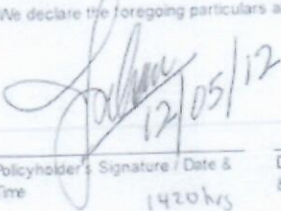
Towards the bent, the lorry came to my lane and subsequently made a sudden stop.
