Brief Details.

On the 13/05/2021 at around 1845hrs, I was riding my motorcycle JLC948 along Sims Way travelling towards Geylang Lorong 8. It is a two lanes road and I am travelling on the left lane. The traffic volume was light at that point of time. I was travelling at around 40km/h and slowing down as I am from the slip road about to filter into the main road. One vehicle SMQ1650Z collided onto the rear of my motorcycle. After the collision, I then fell off from my motorcycle. There was others who then assisted me. The driver also came down of his vehicle to check on me. He asked if I require any medical attention and called for the ambulance. Subsequently, ambulance arrived however, I do not wish to be conveyed. The medics also made a check on me and there was nothing serious.

The damage to my motorcycle is the front headlight and the brake lever. There are some scratches near the exhaust pipe.

There is no vehicle camera attached to my helmet and the motorcycle.

Subsequently, I seek medical treatment at Our Family Physician Clinic & Surgery as I felt pain on my chest area and some abrasions on my left kneecap. I as given 7 days of medical leave form 13/05/2021 to 19/05/2021.
