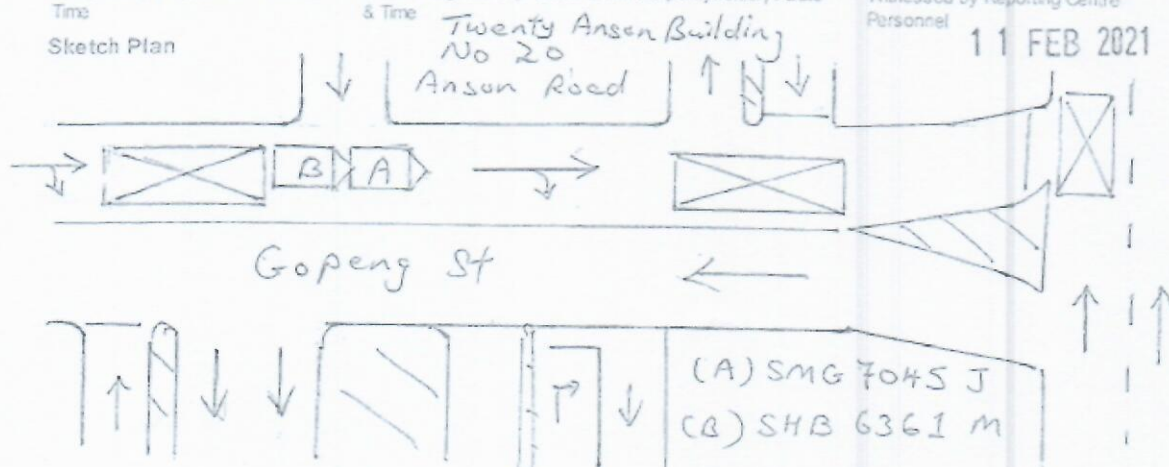

Sketch Plan

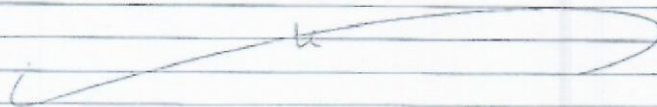
