


SKETCH PLAN

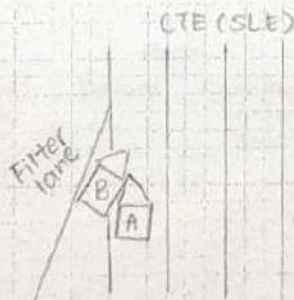
