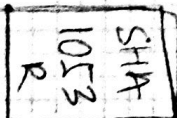
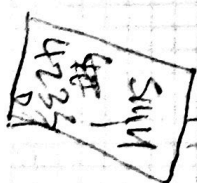
Sketch Plan


