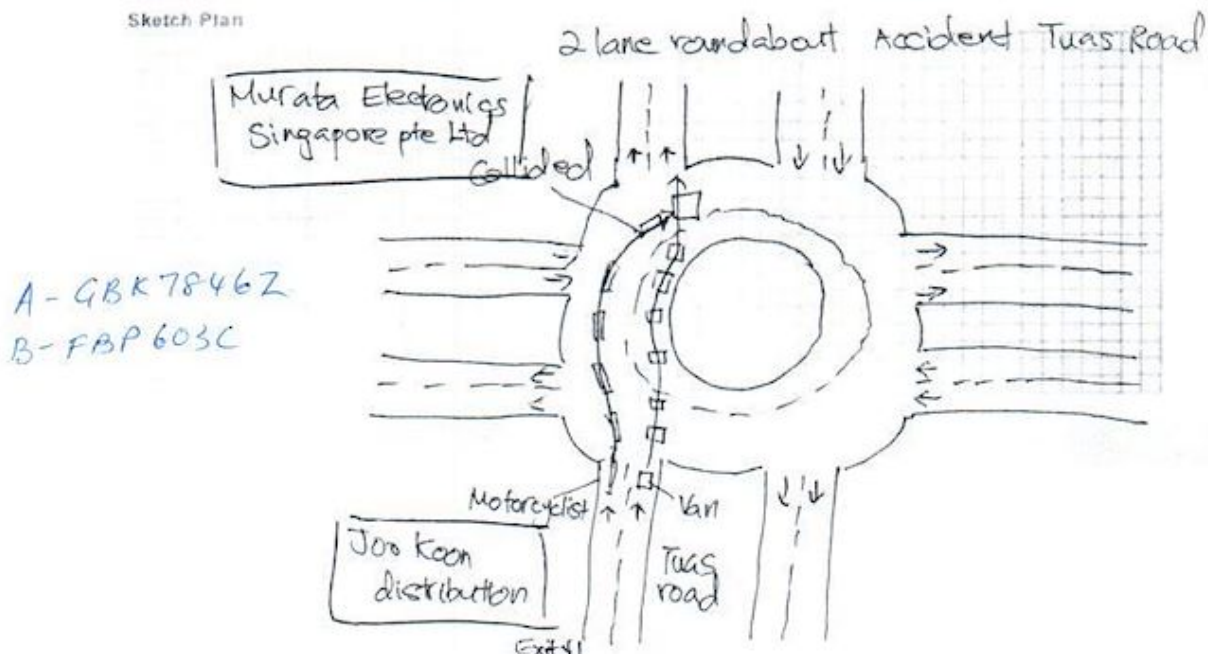

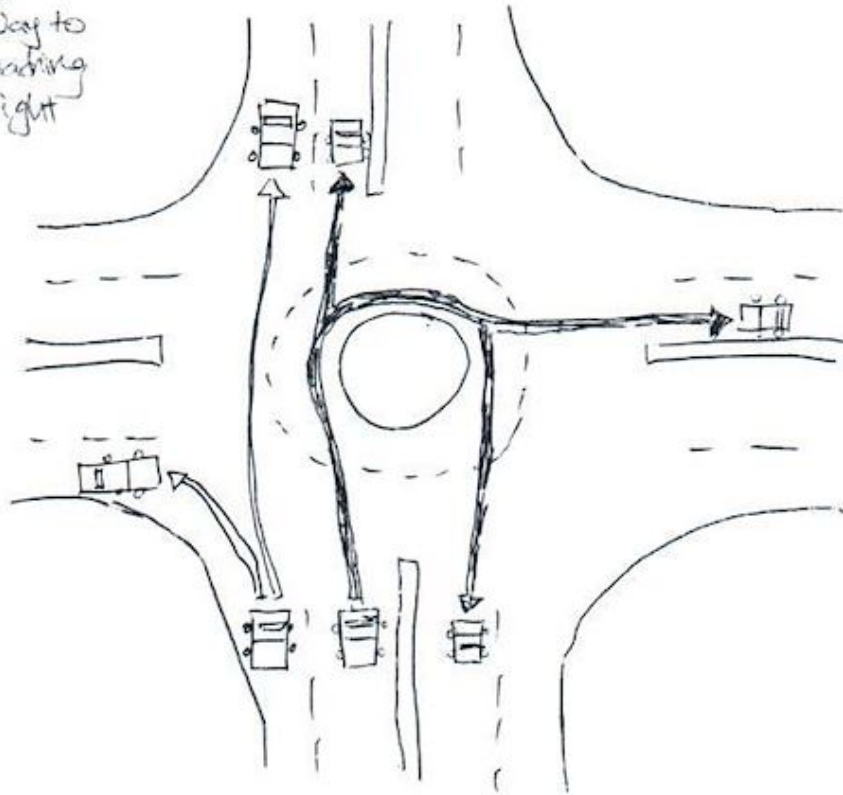
Sketch Plan



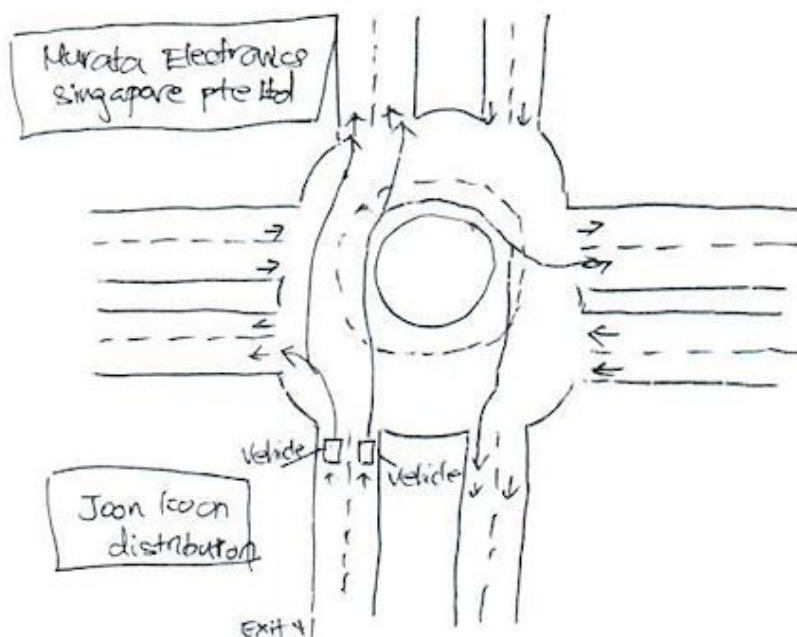
