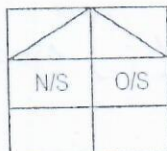

CIRCUMSTANCES OF ACCIDENT

ON 10TH MAY 2021 AT 1525HRS, I WALKED BACK TO MY PARKED CAR INFRONT OF BLK 727, CLEMENTI WEST ST 2, S120727. I OPENED MY REAR DOOR AS TO PUT MY PACKED LUNCH I HAD JUST BOUGHT ONTO THE REAR SEAT OF MY CAR. AS I WAS DOING SO, I SAW ONE LADY INSIDE HER CAR REAR COMPARTMENT. HER CAR WAS ON MY CAR'S LEFT. HER CAR IS SJB1130Y. I PROCEEDED TO CLOSE MY REAR DOOR AND OPENED MY DRIVER'S DOOR AND GOT INTO MY DRIVER'S SEAT. I SWITCHED ON MY ENGINE, CHECKED CLEAR ON BOTH SIDES ON MY REAR-VIEW MIRRORS AND FRONT AND WHEN THE TRAFFIC WAS CLEAR, I SLOWLY DROVE MY CAR OUT OF MY LOT, STILL CHECKING FOR ANY ONCOMING TRAFFIC FROM THE LEFT. HOWEVER, ONLY AFTER MOVING OFF ABOUT A FEW CM, I HEARD A LOUD BANG ON MY CAR'S LEFT REAR DOOR. I IMMEDIATELY BRAKED MY CAR AND SAW THAT FROM MY LEFT, THAT THE LADY'S RIGHT REAR DOOR WAS IN CONTACT (OPENED FULLY) ON MY CAR'S LEFT REAR DOOR. I CAME OUT FROM MY CAR AND WALKED OVER TO THE LEFT TO CHECK THE DAMAGE DONE. THERE WAS A SIGNIFICANT INDENTATION ON MY CAR'S LEFT REAR DOOR. I ASKED HER FOR PRIVATE SETTLEMENT BUT SHE REFUSED AND SAID THAT "IT IS JUST NATURE. YOU DRIVE OFF WHEN I OPENED MY REAR DOOR IT IS NOT MY FAULT." I REPLIED HER THAT WHY SHE OPENED HER DOOR ALL THE WAY SO WIDE AS TO HIT INTO MY CAR'S LEFT REAR DOOR. SHE COULDN'T ANSWER. SHE SHORTLY ASKED ME WITH A CHALLENGING VOICE "YOU CALL THE POLICE LAH" SHE HAD BECOME LOUD DESPITE MY CALM DEMEANOUR. I STILL ASKED HER IF SHE DOES NOT WANT TO PAY FOR THE DAMAGES, WE COULD APPROACH OUR INSURANCE COMPANIES. SHE RETORTED TO CALL THE POLICE AGAIN. I CALLED THE POLICE 999 AT 1533HRS, AND THREE TRAFFIC POLICEMEN ARRIVED AT 1600HRS. THE TRAFFIC POLICEMEN ADVISED US TO PROCEED TO OUR INSURANCE COMPANIES AND WE SHOULD NOT GO AND MAKE ANY POLICE REPORT. THE TRAFFIC POLICEMEN ALSO ASKED THE LADY DRIVER WHO HAD DAMAGED MY CAR'S LEFT REAR DOOR, TO EXCHANGE CONTACT PARTICULARS. SHE AND I EXCHANGED PARTICULARS AT 1611HRS, AND THEN THE TRAFFIC POLICEMEN ASKED US TO MOVE OFF.

Describe Circumstances of the Accident

On 10th May 2021 at about 1525hrs, I walked back to my parked car in front of B1E 727, Clementi West Street 2 Singapore 120727. I opened my rear door so as to put my packed lunch I had just bought onto the rear seat of my car. As I was doing so, I saw one lady inside her car rear compartment. Her car was on my car's LEFT. Her car R/SB 1130Y. I proceeded to close my rear door, and ~~got~~ opened my driver's door and got into my driver's seat. I switched on my engine, checked clear on both sides on my rear view mirrors and front, and when the traffic was clear, I slowly drove my car out of my lot, still checking for any oncoming traffic from the left.

However, only after moving off for about a few cm, I heard a loud bang on my car's left rear door. I immediately braked my car and saw that from my left, that the lady's right rear door was in contact (opened fully) on my car's left rear door.

I came out

I came out from my car and walked over to the left to check the damage done: there was (is) a significant indentation on my car's left rear door.

I asked her for private settlement but she refused and said that "it is just nature, you drive off when I opened my rear door, it is not my fault". I replied her that why she had opened her door all the way so wide as to hit into my car's left rear door.

She couldn't answer. She shortly asked me with a challenging tone "You call the police lah!". She had become loud despite my calm demeanour. I still asked her if she does not want to pay for the damages, we could approach our insurance companies. She retorted loudly that she "had no fault to admit what!". She challenged me to call the police again. I called the police at 1533hrs, and three traffic policemen arrived at 1600hrs.

The traffic policemen advised us to proceed to our insurance companies ~~to~~ and that we should not go and make any police report.

The traffic policemen also asked the lady driver who had damaged my car's left rear door, to exchange contact particulars.

She and I exchanged particulars at 1611hrs, and then the traffic policemen asked us to move off. I duly drove off from the scene and she duly walked away from the scene.
