- E. Below is the explanation of the occurrence of the accident.
 - At about 2.40pm on Wednesday 28 April 2021, I Chee Mee Ding ("CMD") was driving my
 car SLP7122J ("car") along Upper Boon Keng Road towards Boon Keng Road and made a
 u-turn near Geylang West Community Centre to head towards the direction of Kallang
 Bahru. As I cleared the u-turn, the male driver of motor bike no. FR7889R hit the front
 passenger car door on the left side of my car. The door is dented and can still closed. I
 stopped my car to check and found the rider sitting on the road with helmet on and the
 motor bike next to him.
 - While I was talking to the rider, a member of the public called the police and ambulance.The ambulance arrived within about 15 minutes followed by the police.
 - 3. The rider was not communicative. However in response to my queries, the rider said that the motor bike belongs to his father and that he has phoned his father to come.
 - 4. The ambulance staff took his blood pressure and found it normal and there was no visible injuries. The rider said he has some pain in his groin area but no pain elsewhere when asked by the ambulance staff. When his father arrived, the rider went with the ambulance. The father could start the motor bike and wheeled it to one side.
 - 5. I did not see any visible damage to the motor bike.
 - The police officers took the particulars of the rider and I. As requested by police officer Azie Sofia, I produced to her my NRIC and driving licence.
 - The male police officer Sankar told me to lodge a police report and took my in-car camera video memory card and gave me a signed acknowledgement for having taken it.
 Officer Sankar said that the investigating officer to call for in this matter is JOFI at telephone no. 65476960.

Brief Details.
