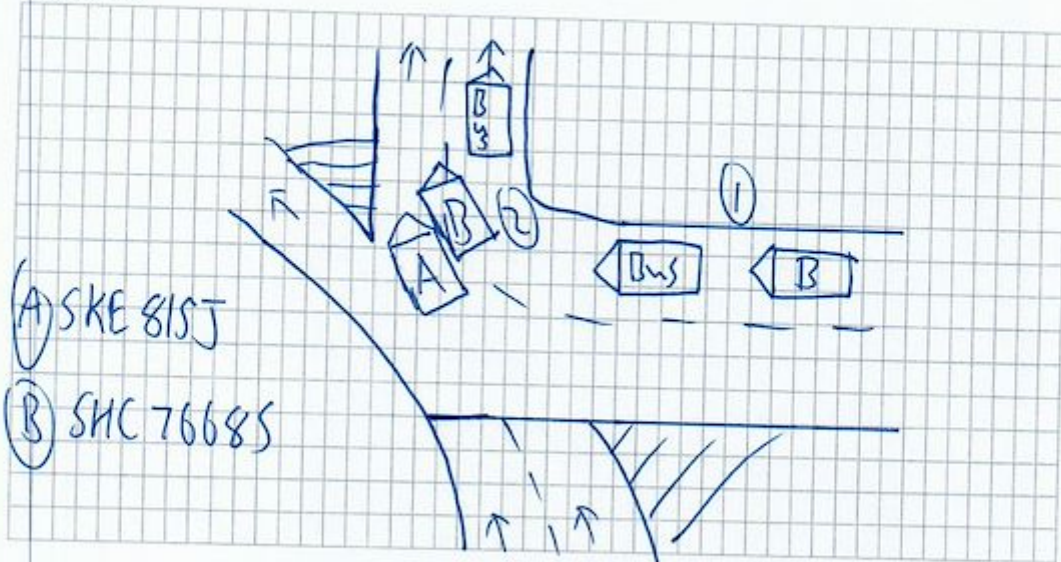

At 10:28:15, lu yu has traveled only a few meters as the spottiswoode sign can still be seen in the photo.

This is also where we can see a bit of the Taxi coming into picture

Then we can see the Taxi cutting fast into lu yu lane. And this is in between lu yu and a bus. This all happen into the same second. 10:28:15. U can see there are 2 passengers in front trying to flag down the Taxi

The Taxi misjudged his ability to cut in between lu yu and the bus...its fortunate lu yu did not accelerate. Taxi was in her blind spot and his action is very unpredictable. Could have resulted in serious injury.
