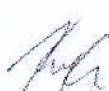

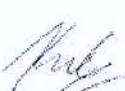

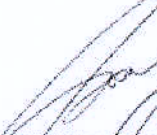

Sketch Plan

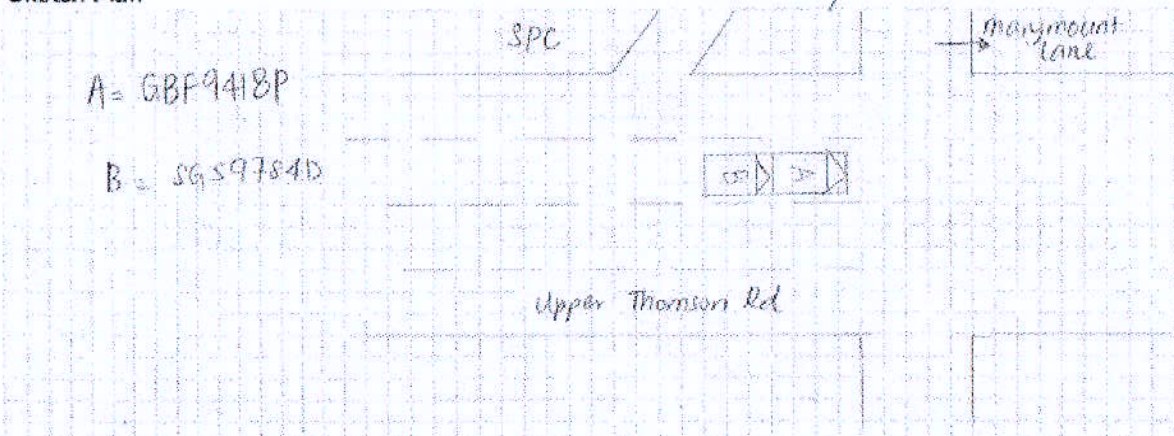

Suddenly I felt an impact and realised that Vehicle B (SGS 9784D) had collided to my rear.

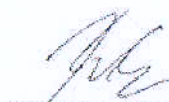

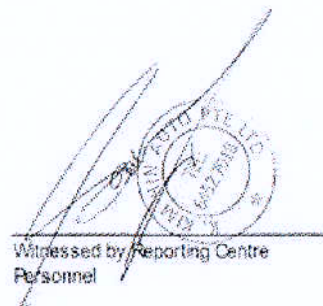
