Brief Details.

On 3 May 2021 at about 2045hrs, I was riding my vehicle bearing plate number FBF3127T on the second lane of Ayer Rajah Expressway. There was a blue Mercedes bearing plate number SMU3149X on my left. The driver suddenly swerved right to enter the second lane without signaling. As I had no time to avoid the car, my handle bar got stuck to the car and I was dragged along before both vehicles came to a stop. I fell off my motorcycle and glided a distance across the expressway. The ambulance subsequently came and I was conveyed to National University Hospital where I received 35 days of MC (Ref: NUH21121566).
