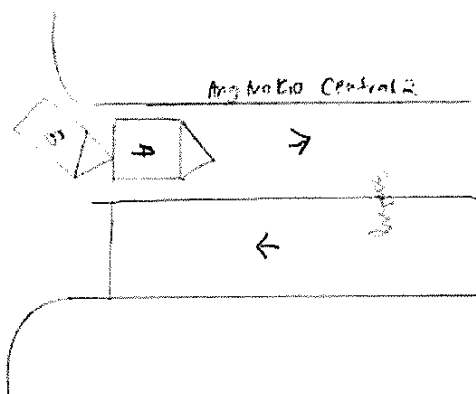

Brief Details.

On the 08/04/2021 at around 1110hrs, I was driving my vehicle SMM6360Z along Ang Mo Kio Ave 8. It was a three lanes road and I am on the most left lane, turning left into Ang Mo Kio Central 2 to the open carpark gantry. There were three other vehicles in front of me waiting for the gantry to open to enter into the open carpark. As the vehicles in front moved forward and I have also moved my vehicle forward towards the gantry, I then felt a collision onto the rear of my vehicle. I then got down of my vehicle to make a check and spoke to the driver of the vehicle SLQ8269H and took photos of our vehicles. We then drove our vehicle into the carpark to exchange particulars and how to resolve the matter. We left the location afterwards as none of us was require any medical attention or to stay at the incident location.

Around half an hour later, while I was driving, I felt that my neck was very stiff when I want to turn my head to the right. I then decided to seek medical attention at Our Family Physician Clinic & Surgery and was given 3 days of medical leave from 08/04/2021 to 10/04/2021.

There is in-car camera at the front of the vehicle which had been taken by my car workshop. My vehicle suffered dent at the rear of the boot and bumper of the vehicle.

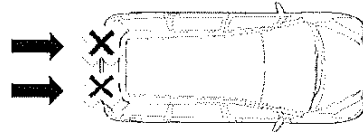
