





I witnessed a hit and run accident involving a lorry 'YQ2549K' from company 'Angliss Singapore' and a Mitsubishi Outlander SUV 'SMR7746L' on 29 May 2021 afternoon.

the lorry reverse, the SUV will shake. Obviously there was impact between the lorry and the SUV.

When the lorry realised I was there and I was actually signalling him to come down from the lorry (for him to leave his particulars). He quickly took off for the exit. The yellow Citycab taxi 'SHD 3306 I' which was there much earlier than I do, reversed to let the lorry pass through.

I couldn't come down the vehicle as there was a silver Honda Stream behind me I didn't manage to record or take picture as I was charging my phone.

I was trying to chase down the lorry but to no avail as he head towards the direction of Hougang Avenue 8.

The driver of the lorry was a bald Chinese, aged late 20s to early 40s, wearing a black tee.
